NEW BUSINESS –

1. Review recreation issues: Brent asked for help, the rec board will accommodate this need. Gary reviewed some of the issues that were brought to his attention on Friday, most of which had already been resolved prior to the meeting. The uniforms need to be the same for all teams. The Rec Board is to set rules and bring them to the City Council for approval. One team has 17 players; more were added after Brent spoke with the Deputy Clerk to let her know that we were not accepting anymore applications. Lack of communication seems to be the biggest issue. All coaches need background checks and a signed code of conduct. A practice schedule will be made to rotate all teams so each one can use a “real” field. The new Recreation Board will consist of: Timothy Garner, April Cook, Shaina Prevatt, Cecil Roche, and McKenzie Faison. Brent asked about the members from the previous year including Jennifer Anderson and Kristen Garner; Timothy requested that they be placed on this board as they were integral last year. The Council agreed to the extra two rec board members. Until the background checks are complete and approved, coaches do not need to be on the field at all.
