RECREATION REPORT at this point we do not have enough to make a football/cheer team but PYFA has pushed the starting date back to August 3rd

PUBLIC WORKS' REPORT we've been mowing grass, Moss Hill, the Cemetery are complete and City Hall is almost finished; Joey asked how many working lawn mowers the city has which is 3-one of which he gave to the recreation department; Gwendolyn asked about the tractor on Moss Hill, the City Clerk replied that she had been in contact with Asplundh and they are trying to figure out if it belongs to the Alabama or Florida office

the end of the line; I was there this morning and the clog is in his yard, we are going to put a clean out on the City's side.
