1. **City Cemetery** Joey Brock opened the meeting by stating that the City has recently acquired the cemetery from a group that used to own it, the survey has been complete, but now we are facing some boundary issues on the south end of the property as we have about 20 graves outside of the boundary lines; the surveyor said that no judge would make us move the graves; the City is working with the Hicks family to try to obtain this property and possibly more that they have, right now no one will be buried at the south end of the property; the north end of the cemetery also has some issues as there is a 30' easement therefore most of the property on the south side of Circle H belongs to the city even though this property is being used by Gary Haddock for Circle H parking and truck entry; the City Clerk will contact the local funeral homes to let them know to contact us before any burials are authorized; Larry suggested locking the cemetery at a certain time every night like other bigger cemeteries have done; our cemetery has been let go for many years and needs a lot of attention; Larry Pippen then suggested a "Cemetery Day" to have the citizens come out and help clean up; we have a cedar tree that needs to be taken down
