2. **Recreation Department** – Joey opened by saying, we have a regular employee and a contract employee, we have to give the contract employee 30 days and the regular employee nothing, I don't see keeping McKenzie we've all seen the pictures, we had 2 ball tournaments down there that had nothing to do with the City, they should have come back the next day and cleaned up as we are losing still money and are probably going to have to replace a lot of the food that is still in the concession stand; Gwendolyn March made the recommendation to terminate McKenzie Faison's employment; Timothy asked if he could weigh in and stated that McKenzie has the knowledge and ability to take care of this I think she needs to be kept on board and given another opportunity, set some expectations for her and let her know explicitly what is expected of her and a time frame and then go from there; Jeanie Shipes made the second to terminate employment; the motion passes with a 4:1 vote; we will look at re-working Timothy's contract; once the bathrooms have been cleaned, they will be locked and the City Clerk will order signs letting citizens know to contact City Hall during regular business hours for access; we will discuss the recreation department further at the next workshop; we need to have a separate workshop on 9/14
