MAYOR'S REPORT I received an email today regarding a mandatory webinar for the City regarding Hurricane Sally; several vendors have contacted me regarding the bazaar; I attended the Fire Department meeting 2 Tuesdays ago; 12\12 is our parade and bazaar

ATTORNEY'S REPORT the survey of the track will be underway shortly

CLERK'S REPORT DPS (collection agency) is working hard at getting money for the City; Timmy and volunteers have been working hard at the Sportsplex; we need power to the scoreboard at field 2 at the Sportsplex and internet at Shady Grove; Full Circle Teaching (King's Dowry) they believe some of their water was stolen; Action Fire Safety is in the process of inspecting our fire extinguishers, but we do have an issue at the Sportsplex the tank needs a gas shut off valve, they are working on a price for that; Ten-8 has submitted a quote to fix the tanker \$646.96, added to the agenda as #6

FIRE CHIEF'S REPORT the inspection for the tanker has been postponed to 12/18/-12/19; we have only had minor calls

RECREATION REPORT presented by the City Clerk - Shaina reached out to Timmy asking if a vendor can rent the concession stand for \$300.00 on top of the 20% of sales, the Council discussed charging a cleaning deposit as well, this was added to the agenda as #7; Timmy and the Clerk both understood that the deputy will be paid out of the gate fees up front and then the City will receive their percentage; Timmy has over \$16,000.00 in his budget for signs and scoreboards and would like to use \$6000.00 of that for a John Deere Mule, added to the agenda as #5

PUBLIC WORKS' REPORT everything is going well; we need the auto-dialer operational (has not been connected since Gerald was here) before we can get our permit renewed

PUBLIC PARTICIPATION: Rhonda Dickinson : ROTC put flags out at the cemetery ; every grave has been pressure washed; the cemetery committee is researching ground penetrating radar to look for unmarked graves and getting estimates
